- If seller fails to deliver 95% of merchantable sheep sold, seller shall be liable for freight adjustment, replacement of like sheep and/or monetary adjustment based on prevailing market price of like sheep. Current Lamb Checkoff fee will be deducted.
- No Sale Charges: \$0.75 per head on feeder lambs; \$2.00 on replacement and bred ewes.

I agree to pay all weighing and health charges. Scales used must have a current certification.
