## Terms and Conditions

- Pregged open heifers must be tested 21 days prior to shipment.
- The buyer has the right of refusal if average weight of cattle is 60 lbs. or more over the base weight at delivery. Contract will then become null and void. Seller will reimburse Western Video Market, Inc. for deposit received.
- If seller fails to deliver 95% of merchantable cattle sold, seller shall be liable for freight adjustment, replacement of like cattle and/or monetary adjustment based on prevailing market price of like cattle.
- Seller will be liable for \$5.00 per head on non-brucellosis-vaccinated (Bangs) heifers if sold to a buyer requiring it by interstate or applied intrastate laws.
- Seller will be liable for any deductions made by buyer on any heifers sold as feeding heifers if preg tested with calf within 7 days of delivery.
- No Sale Charges: \$5.00 per head on stocker/feeder cattle.
- A partial payment of \$80.00 per head is due to seller on the date of purchase, if cattle ship 10 days or later after the auction. No deposit will be paid to seller if cattle ship within 10 days of delivery.

I also warrant that cattle are free of all liens and encumbrances except as below. Scales used must have a current certification. Seller gives permission to Western Video Market, Inc. to sign sales/purchase contract in lieu of seller's presence after the sale.
